NOTICE OF PROPOSED AMENDED REGULATION

REGULATION CHAPTER NO.: Chapter 2

REGULATION CHAPTER TITLE: Student Affairs

REGULATION TITLE AND NUMBER: Student Meal Plan - 2.026

SUMMARY OF REGULATION: The amendments reflect the current requirements for participating in the Meal Plan, defines traditional residence halls, and deletes obsolete language.

AUTHORITY FOR REGULATION: Article IX, Section 7(c) Florida Constitution, and Board of Governors Regulation 1.001.

UNIVERSITY OFFICIAL INITIATING THIS REGULATION: Dr. William Hudson Jr., Vice President for Student Affairs.

PROCEDURE FOR COMMENTS: Written comments concerning this proposed regulation shall be submitted within 14 days of the date of this notice to the person identified below.

FULL TEXT OF THE PROPOSED REGULATION: The full text of the proposed emergency regulation follows:

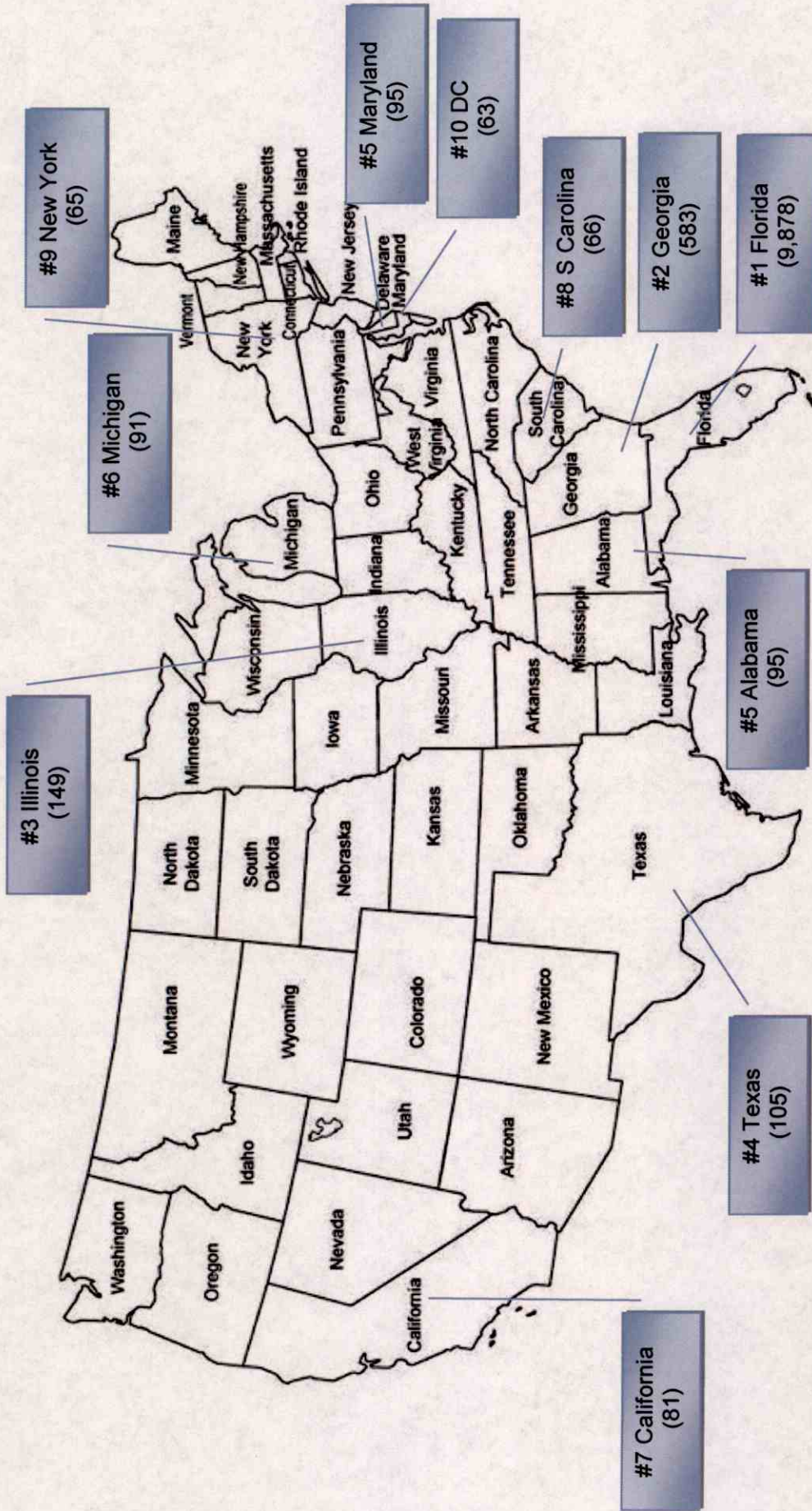
2.026 Student Meal Plan.

(1) All students residing in traditional University residence halls ~~will~~ shall participate in ~~the~~ a Mandatory student meal plan. Traditional residence halls are Cropper, Diamond, Gibbs, McGuinn, Paddyfoote, Sampson, Truth, Wheatley and Young Halls, and the 800-bed housing facility yet to be named. Each student requesting housing in a traditional residence hall must select a Mandatory Meal Plan option by the second week of class during the Fall, Spring and Summer semesters. If a student fails to select a Mandatory Meal Plan, he/she will be automatically enrolled in a Mandatory Meal Plan Option. Mandatory Meal Plan Agreements are an annual commitment for the Fall and Spring semesters. Students enrolled during the Summer semesters that reside in a traditional University residence hall are also required to sign an agreement for this term. Each meal plan offers a variety of meal options satisfying varied dietary requirements, personal tastes and individual schedules. Each plan provides at least 15 meals per week and provides unlimited seconds for all meal plans eaten in the resident dining facility. The following meal plan options are available: The fifteen (15) or nineteen (19) meal plan and the fifteen (15) or nineteen (19) equivalency meal plan. The equivalency meal plans may change from year to year. The specific meals to be offered in each option and the cost for each option will be furnished to all students at the time they request housing information. 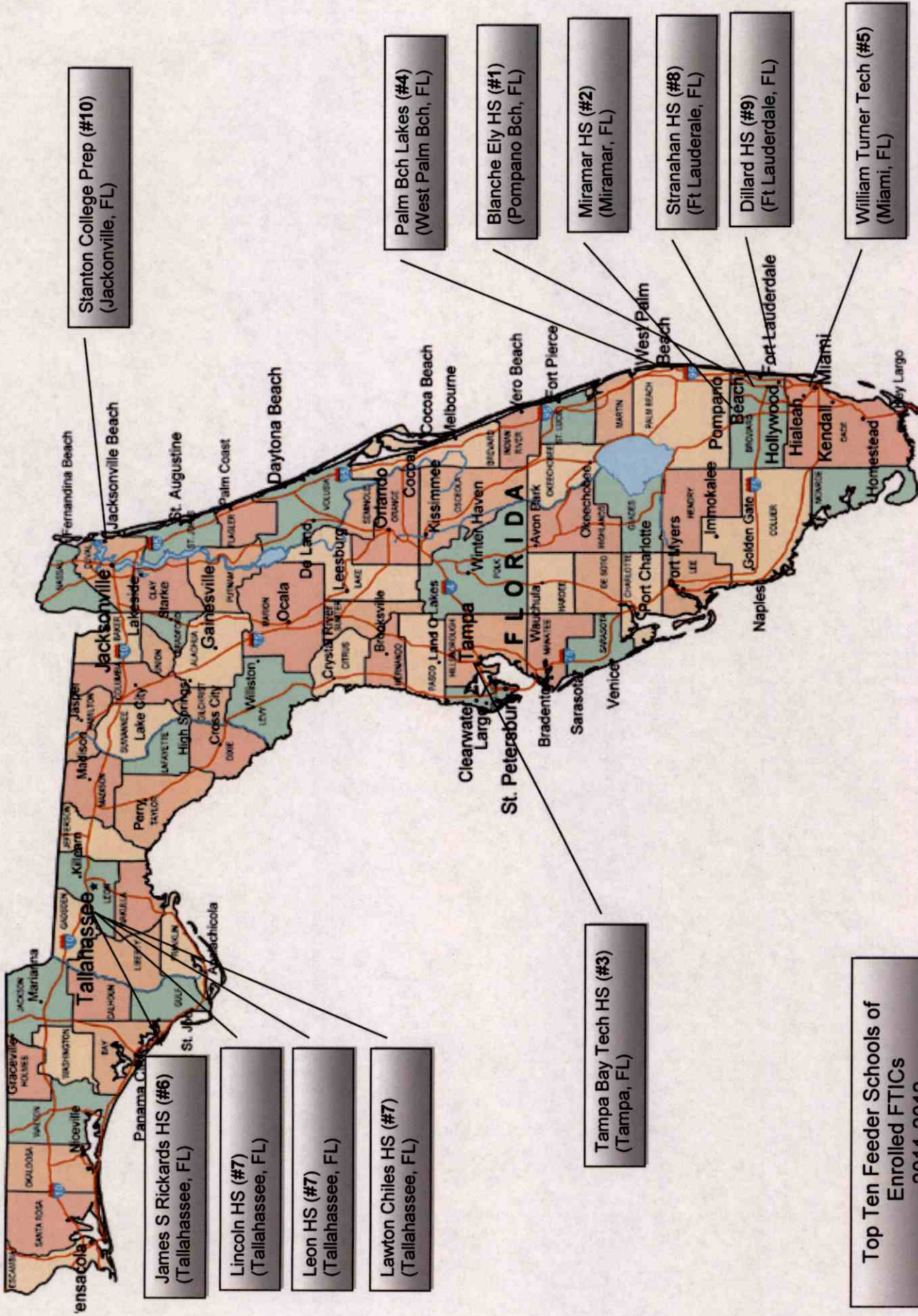
- (2) If a student is assigned to a traditional University residence hall which requires a meal plan, but transfers to a residence hall that does not require a meal plan, the student is obligated to pay for the meal plan based upon a pro-rated amount according to the number of days she/he resided in the traditional University residence hall. If the student has been approved for a cancellation in accordance with the Housing Agreement Terms and Conditions, a pro-rated portion of the meal plan not used by the student may be provided.
- (3) ~~Each student requesting housing in a traditional non-apartment residence hall must select a the fifteen or nineteen meal per week option at the time the student receives his/her Rattler Card (Official University Identification Card).~~ On-Campus apartment-style residents and Non-residential students may also participate in both the Mandatory ~~and~~ or the Commuter ~~the Student~~ Meal Plans, which is available for review on-line at <http://www.famudining.com/plans.html>.
- (4) Each diner must present his/her current Rattler Card to access dining services.
- (5) All meal plans, including flex dollars, expire at the end of the semester.
