N. Old Business

i. CAB25FA-001 The Formal Integration of Mister Titles to the Royal Court

- Vice chairman Askew stated that according to SB 266 prohibits states finds to be used for gender specific roles
- Miss FAMU, Edwina Fleuridor, requested that there is a formal meeting with the royal court since they would be affected by this bill

- Miss FAMU states that adding a hierarchy to the royal court will ruin the tradition that FAMU has set; states that there is no money
- Miss FAMU recommends a panel for transparency to the students about what the royal court does; the decision to have Misters may have been a decision made without the proper knowledge
- Pro-Tempore Person moves to open the gallery for 2 mins
- Senator Gaines moved to open the gallery until the end of the discussion
- Miss FAMU explains that a panel selects the Royal Escorts instead of an election being held
- Pro-Tempore Person states without the input of the student body, there would be no Mr. FAMU
- Pro-Tempore Person states that the viewpoint and job of the senate is to serve the student body as a whole
- Vice Chairman Askew mentions that there is still a chance that within the selection of the escorts, there will be representation of the student body
- Royal Court Escort mentions that the escorts are able to represent the values and integrity of FAMU a lot better now versus there being an election
- Chairman McClover states that with the current selection process, every male on campus does not feel like they have the same opportunities; the royal court is supposed to be representation of the whole school
- Pro-Tempore Person moved to place us in open discussion
- Chairman McClover states that their will be a formal meeting with the royal court and the committee
- Chairwoman Braclet inquires on the purpose of closing the meeting to just those two entities
- Senator Gaines states that she is going to gather all of the questions that the senate has and speak on their behalf
- Senator Barnes asks Miss FAMU about the execution of representing the student body while trying to appeal to FAMU's tradition; she asks how one can be done without neglecting the other
- Mr. FAMU states that the student body should trust the committee and the people in which they elected
- Chairman McClover moves to table this bill until the next senate meeting

O. New Business

- i. SR25FA-001 Concert Ticket Pricing
- Pro-Tempore Person moves to place this bill on second reading
- President Brown inquires on how much of the revenue is coming back to SGA

- VP Williams said that SGA contributed 300,000 dollars to the show; it is a 600,000 show
- VP Williams states that the projected revenue from this concert is about 850,000 to 1.1M; bigger revenue pool based on the level of artist; split 75/25 at low rate
- Senator Barnes inquires about the pricing of the student tickets versus the VIP ticket
- VP Williams states that the price of the floor tickets are at a flat rate because they are limited; the \$50 tickets will increase every two weeks as we get closer to the concert
- VP Williams states that even though the tickets look higher on paper, they are very cheap considering who will be performing; ticket sales begin Friday
- Pro-Tempore Person moved to accept the ticket prices for the Homecoming Concert
