i. CAB25FA-001 The Formal Integration of Mister Titles to the Royal Court

- Senator Gaines stated that the biggest discussion point that was deliberated on was the difference between culture and tradition
- Chairman McClover stated points that Ms. Thurman stated within the meeting
 - i. Ms. Thurman previously stated that most of the escorts that are chosen are not the campaign type
 - ii. More money would be included with funding and individually
 - iii. Platform points have to align with the attendant of that class
 - iv. If they are going to be called misters, they should get a sash
 - v. There has been a lot of interest shown over the past years for the informational meeting about escorts
 - vi. She shared her disappointment in the fact that all of the escorts last year pledged Alpha; this may have fueled the rumors of there being bias in choosing escorts
 - vii. According to the advisors, the fact that many pledged had no correlation to the interview process
 - viii. She stated that making it election based would turn it into a popularity contest
 - ix. It would add 2 more people to the court in the Fall without the proper summer training
- Chairman McClover shared some of the concerns Ms. Mallory held in the meeting
 - i. The escorts only receive five hundred eightythree dollars apiece; money would have to be raised for the other items
 - ii. Suggested that one additional escort to be selected rather than elected
- Chairman McClover stated that there is no legality issue in regard to Senate Bill 266
- Senator Gaines moved to open the gallery
- Chairman McClover stated that the rumors of there being bias are indeed facts; there is bias involved
- Ms. Thurman suggested there still be a formal meeting with the royal court
- Ms. Thurman states that everyone on the committee gets
- Senator Gaines moved to be placed in open discussion
- Pro-Tempore Person states that the bill will not be affected during the current constitutional amendments

- i. SPB25FA-001 Amending the Internal Rules of Procedure Regarding Senate Appointments
- ii. SR25FA-002 Financial Literacy Expansion Resolution
 - The bill went through the proper channels
- iii. SR25FA-003 Advocating for Freshman Access to Student Organizations
 - Senator Barnes moved to place this bill on second reading
 - Senator Barnes explains that the point of this bill is to waive the entire regulation so that everyone can join
 - Senator Gaines moved to open the gallery for 3 minutes
 - Pro-Tempore Person moved to open the gallery until the remainder of this bill
 - Mr. K recommends that the arts organizations move to being an open organization
 - Ms. Mallard clarifies that even if this bill is passed today, it will not be going on the BOT meeting agenda this week
 - The regulations are being reviewed as of now
 - They are not able accept members in the fall, but they can in the spring
 - Senator Gaines recommends that this bill is tabled until the meeting about regulations can happen
 - Chairman Williams suggest adding that you must be a full-time student rather than having a credit hour amount

- Senator Louis reflects on the experience regarding this regulation; she states that people not being able to join organizations based on credit hours is unfair
- SGA President Bryant states that this is a university regulation; it is not within our jurisdiction to change
- Ms. Mallard request that the makers of this bill go through the proper processes
- Senator Gaines moves to table this piece of legislation; the against has it
