Please take into consideration the precedent that is being set for future actions & leaders and how rolling over every time doesn't solve anything and allows room for continued behavior.

- Senator McClover had shed more information and explained the decrease of the budget was so the University can take more responsibility

- Vice Chairwoman Brown: pushing elections back would affect attendants
- President Bryant: Clarification of the adding additional day to declarations delaying election schedule

- Was discussed that there was no bill that puts a rule on how EC should reschedule after school closure
- President Bryant asked a clarifying question on why adding an additional to the schedule would delay the elections of the standard period of declaration would permit the same amount of time in between the last day to declare and declaration day?
- Vice Chairwoman Brown: Pushing back elections would affect attendance of the candidates' campaigns
- Joint Ops added the possible ramifications of not adding the extra day and a possible open investigation

- Sarah Wilson, puts emphasis that candidates had enough time, and it should only take a minute
